#### Ask the Pastor

**Question:** Does God really hear our prayers? What if I'm not praying the right way or saying the right words or I fall asleep before I'm finished praying at night?

**Answer:** "In the same way, the Spirit helps us in our weakness. We do not know what we ought to pray for, but the Spirit himself intercedes for us through wordless groans." < Romans 8:26 > NIV

This question is most likely shared by everyone at one time or another including myself at points in my life. Sometimes we pray and pray and pray but do not see the results we expected and wonder, 'does God really hear our prayers?'

We also play the guilt card and imagine we just aren't doing it the right way or saying the right words or we feel maybe we just are not sincere enough because we can't stay focused while praying.

We are Christians and that means we are disciples of Jesus the Christ. Our hearts and minds are opened by his teachings and his actions. These are the blueprints of Christian thoughts and actions for us to follow on a path to stay in relationship with God as Jesus' followers.

I think it is notable to consider we are not the first to question our prayers. The original twelve disciples also were unsure of how to pray and what to say. "One day Jesus was praying in a certain place. When he finished, one of his disciples said to him, "Lord, teach us to pray, just as John taught his disciples."" <Luke 11:1> and Jesus taught them the Lord's prayer that we still pray to this day.

But how do we know for sure that God hears our prayers? We are disciples of Jesus the Christ. We have been baptized as children of God and become brothers and sisters of our Lord and Savior. We know that what he taught us is true. There are many scriptures that tell us of God's attention to our prayers, but for me there is one spoken by Jesus that gives me assurance. It comes from the story of Lazarus raised from the tomb. "So they took away the stone. Then Jesus looked up and said, "Father, I thank you that you have heard me. I knew that you always hear me... < John 11:41-42a>


In these words, Jesus assures us that God does hear his Son and in the same way all of his children which are all Christians. "I thank you that you have heard me. I knew that you always hear me." So why do we doubt and wonder if God hears our prayers? Jesus tells the disciples of his time, and you, the disciples of this day, that they will be persecuted. Indeed, many have been persecuted and even put to death for their belief and pronouncement of Jesus as Lord.

But there is another persecution that isn't as obvious as the stories of those who have been put in prison or even killed. The other is the persecution from the devil himself and it isn't a physical harm, but one of deceit and beguilement. What you hear in your mind is: 'Why would God listen to you? Didn't you say mean things to that person today?', 'There are billions of people in the world, you can't expect God to hear all those prayers', 'Your life is a mess, you are not worthy of God's attention!'

If you listen to the devil and fall for his deceit, then you will also fall away from prayer and give up. Then you may drift away from God and your relationship becomes broken. This is the devil's intent. Believe in Jesus' words and turn a deaf ear to the devil. Know that God hears your prayers and when you do not know what to say, "the Spirit himself intercedes for us through wordless groans." "Father, I thank you that you have heard me. I knew that you always hear me..."

#### Congregational Council Meeting, July 13, 2020

A Congregational Council meeting called to order by President Zola Finch at 6:30pm on Monday July 13, 2020 in the church basement with social distancing in compliance with Covid-19 guidelines. Present were council members Zola Finch, Laurie Koestner, Kathy Meller, Paula Linsenbardt, Dan Tschirgi, Delores Vlach, Mitch Plochberger and Becky Weber. Absent was Scott Soell. Also present was Pastor David Viles and Council Treasurer Kay Pascoe. The meeting was opened with a prayer by Pastor Viles, followed by a devotion from Philippians 4:6-7," Do not be anxious about anything, but in every situation, by prayer and petition, with thanksgiving, present your requests to God. And the peace of God, which transcends all understanding, will guard your hearts and your minds in Christ Jesus." Pastor said that when we look to our human nature only, we make decisions based on our thoughts and emotions. The prominent emotion we rely most on is fear. Every decision in some way is based on how a situation will directly affect us personally or someone we care about. But there is another nature and it is the Spirit, in our trust of God's grace to guard our hearts and minds in Christ Jesus. This freedom that brings joy and not fear comes from our relationship with God and our faith and trust in His care of for us. When we relinquish control to God and trust in His care of us we can find joy and hope in a life that is otherwise restricted and crushed by our nature of human anxiety. As we yield our control to God, and as we go forward with decisions to be made concerning the health and safety of our congregation in this time of the pandemic, we can accept God's nature to unite with our human nature and allow God to show us His will which transcends all understanding.

President Finch called for approval of the previous council meeting minutes. A motion to approve was made by Dan Tschirgi, seconded by Mitch Plochberger, and passed via voice vote.

President Finch directed the council members to the treasurer's report distributed by council treasurer Kay Pascoe. Kay Pascoe called for a \$500.00 donation to Samaritan Center. President Finch called for a motion to approve aforementioned donation and to address this request on an annual basis in July. Paula Linsenbardt made this motion, seconded by Kathy Meller, and passed via voice vote. A motion was made by Laurie Koestner to approve treasurer's report, seconded by Mitch Plochberger, and passed via voice vote.

Pastor David asks that he be allowed to donate the 23 miles he drove this past month, and this was accepted with thanksgiving by council members. He reported the following activities for June, 2020: Confirmation at Wasserlauf, preached message for baccalaureate senior students at Cole R 1 Russellville High School, picked up mail at post office while Marie has been out, opened church friendship hall for voting, closed up afterward, created epistle for July, emailed on June 30, 2020, postal mail on July 1, 2020. Pastor reported on the following meetings: Worship and Music email exchange, Church Council, City Council, Mutual Ministry, and Ministerial Alliance. He had several phone conversations and consultations. Services for June include four online services at St. Paul's using Facebook Live and four in house worship services using Social Distancing and Covid-19 guidelines, with a Confirmation service on June 21, 2020.

President Finch called for the Standing Committee Reports which are included below.

**Old Business:** President Finch offers that she will revisit our current Covid-19 procedures.

**New Business:** President Finch will compile a list of all church positions for next month's council meeting that will need a backup person to perform duties in the event of an unforeseen absence.

#### **President Finch**

Called for a motion to adjourn. A motion to adjourn was made by Laurie Koestner, seconded by Paula Linsenbardt and passed via voice vote. Meeting adjourned at 8:45 pm.

Pastor David closed the meeting with a special prayer.

**Evangelism:** Delores Vlach reports it was decided to table the decision on whether or not to hold Church Family Day until the August council meeting due to Covid-19. She also reports there will be no snacks/drinks at the August 4, 2020 election due to Covid-19. It has been decided to cancel this year's chili supper due to Covid-19.

**Technology:** Dan Tschirgi presented a bid from The Entertainer for possible purchase of equipment for enhanced service broadcasting. After discussion, President Finch called for a motion to purchase equipment from The Entertainer with added AT&T hot spot internet service as required for the approximate amount of \$4,500.00 with the understanding funds for such will come from private donations. A motion was made by Mitch Plochberger, seconded by Kathy Meller and passed via voice vote.

Worship & Music: Kathy Meller reports the August hymns were chosen for worship services. Pastor David was thanked for recognizing our veterans during our patriotic worship service. After much discussion, because of the recent spike in the number of active Covid-19 cases in Cole county, it was decided we will continue to abide by Covid-19 guidelines put forth by Church Council and not sing during worship services. We will revisit this issue at the August Church Council meeting. After discussion, it was decided we will begin having Holy Communion in August using Covid-19 safety guidelines. President Finch and Kathy Meller were thanked for playing at our worship services.

Parish Education: Laurie Koestner reports she will post a sign-up sheet for God's Work Our Hands T-shirts and check into possibly having a church work day in service to community members in need of yard work cleanup. Laurie reports she will check with ELCA, other local churches and Cole R 1 School regarding guidelines in reopening our Sunday School.

**Church Improvement:** Mitchell Plochberger will obtain price quotes regarding cost of a flag pole on our church property. Mitch will email our church insurance company regarding parsonage roof replacement.

Stewardship: Paula Linsenbardt - No report

**Mutual Ministry:** Scott Soell, absent. Pastor David reports Mutual Ministry is in the process of performing Staff Evaluations that need to be completed by September of 2020.

The new method of the people staying in their vehicles worked pretty good. We started a little early serving the families since we were ready and it was a hot afternoon. Some of the items given away were dry beans, red potatoes, dairy boxes containing milk, sour cream, cottage cheese, frozen chicken nuggets, frozen non-meat patties, salad bowls, bags of onions, multi-colored peppers and 'Shout It Out' spray. We had thirteen volunteers that stayed busy. From the Lohman Lions Club was Alberta and Gary Zumwalt, from St. Paul's Lutheran was Rosemary Heidbreder and Audrey Bunch.
